Subject: Intimation of Show-Cause Notice received from SEBI by Mr. Ramesh Kunhikannan, Managing Director of Kaynes Technology India Limited, under Rule 4(1) of SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995 in the matter of insider trading in the scrip of the Kaynes Technology India Limited (“The Company”).

In accordance with the provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that Mr. Ramesh Kunhikannan, Managing Director (“**Noticee**”) of Kaynes Technology India Limited has received a Show-Cause Notice dated March 10, 2025 (“**Notice**”) from the Securities and Exchange Board of India (“**SEBI**”), details are mentioned in **Annexure A**.

The Notice alleges suspected violations in maintenance of Structured Digital Database (SDD) pertaining to financial results for the period ended March 31, 2023 as per Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 (herein after referred as “**PIT Regulations**”).

We are currently reviewing the contents of the Notice and will take all appropriate legal and procedural steps, including providing a timely response to the SEBI. The Company, Noticee and all concerned remain committed to fully cooperating with SEBI to resolve this matter in accordance with the applicable legal and regulatory framework.
